# THE FRAYED AMERICAN SOCIAL SAFETY NET



We won't be making history in this course by stating that the American safety net, the group of programs intended to help people when they lose their jobs or otherwise come upon hard times, is full of holes. People who don't need help, by most definitions, get it, and those who need it most sometimes get very little. Why is this? Is this a result of Reaganism? Does the phenomenon predate Ronald Reagan, and if so, what do we trace this back to?



In this course we will look at the programs listed below with a goal to answering several questions:

- 1. How important is the program in alleviating poverty and keeping people from falling into poverty? What programs keep the most people out of poverty and how do they do that?
- 2. What is the goal of each program? How does it accomplish the goal? What group is included in the program and what group is omitted and why?
- 3. To what extent are the funds on the program targeted and on what group? What impact does the targeting have on the politics of each program? (over  $\rightarrow$ )

The safety net consists of programs in three categories: (1) Social insurance programs tied to factors such as employment or old age: Social Security Retirement and Survivors Benefits; Disability Insurance; Medicare; Unemployment Insurance; Workers' Comp. (2) Means-tested transfers conditioned on low income or low assets: Medicaid; Supplemental Security Income (SSI); Temporary Assistance for Needy Families (TANF); housing assistance; childcare subsidies; Supplemental Nutrition Assistance Program (SNAP). (3) Means-tested programs tied to employment: Earned Income Tax Credit (EITC); Child Tax Credit (CTC)



**TED ANAGNOSON** received his PhD in Political Science from the University of Rochester in New York and taught at Cal State LA and UCSB for 40+ years. He is professor emeritus in political science from Cal State LA. In retirement, he edits the California State University Emeritus and Retired Faculty Association quarterly newsletter and teaches periodic courses for VISTAS Lifelong Learning, in addition to currently serving as our organization's co-president.
